

OFFICIAL RULES FOR THE "Renew To Win Sweepstakes"

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The Renew To Win ("Sweepstakes") begins on August 5, 2019 at 12:01 a.m. Pacific Time ("PT") and ends on September 13, 2019 at 11:59 p.m. PT (the "Sweepstakes Period").

HOW TO ENTER: During the Sweepstakes Period, there are two (2) ways to enter: (1) Renew your 2020 FanShield 500 NASCAR weekend race tickets by mail, phone, or website to receive one (1) entry into the Sweepstakes; or (2) Via Mail: Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and date of birth on a 3" x 5" card and mail the card, with proper postage affixed to: Renew to Win Sweepstakes c/o ISM Raceway, 125 S. Avondale Blvd., Suite 200, Avondale, AZ 85323. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address, and per household. Entries received from any person or email address or household in excess of the limitation will be void.
